With this benefit, you can decide where you fill your prescriptions for medications you take regularly.

#### Your choice, your way

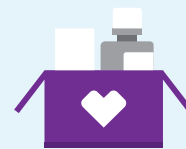
After two retail fills, you can get a 90-day supply of your maintenance drugs at a discounted rate from a participating mail service pharmacy or at selected participating retail providers.

#### How to opt out

You can opt out of Maintenance Choice<sup>®</sup> for all your maintenance medicines. Just let us know that you'd like to continue to fill your 30-day supply at your retail pharmacy.

If you opt out, you'll pay the regular retail copay for your 30-day supply. If you don't opt out, you'll pay the full cost of your medications on the third fill.

# Let's get started

Getting 90-day refills for the medicines you take regularly is easier than ever.

**1. If you're filling your prescription at a local participating 90-day retail provider,** your pharmacist can change your prescription to 90-day refills.

**2. If you're not filling your prescription at a participating 90-day retail provider** and would like to switch to a mail service pharmacy:

- **Call Customer Care at 1-888-Rx-Aetna (TTY: 711) or 1-888-792-3862 (TTY: 711).** We'll contact your doctor for a new prescription and handle all the details.
- **Order online.** Visit the website that's on your member ID card, and then sign in to your account to submit your order.



## Delivery options

Your local selected participating retail provider may offer delivery options for a nominal fee.

Your selected participating mail order provider will offer shipping options, including free or expedited delivery.
